

**Washington County Democratic Central Committee
August 26, 2020 Regular Meeting
Minutes**

The electronic credentialing process started at 6:30 pm

1. The Meeting opened at 7:05pm. Officers present were: Patrick Maguire (Chair), Martita Meier, (1st Vice Chair), Amelia Manlove, (2nd Vice Chair), Veronica Williams (Treasurer) and Victoria Long (Recording Secretary). - ❖ Garrett Fleenor moved (CC8262020-6) to limit debate to 10 minutes. Seconded by Jim Silver. Vote: 70-YES, 7-NO (starting at 8:51pm).
- ❖ Jim Silver moved (CC8262020-7) to end debate. Ms. Bender-Phelps seconded. Vote: 67-YES 11-NO. Debate ends on dual endorsement motion.
- Vote on (CC8262020-5): 24-YES 56-NO. Motion to make this a dual endorsement fails.
- ❖ Jim Silver moved (CC8262020-8) to end debate on the motion (CC8262020-4). Seconded by Mr. Gallup. Vote: 57-YES 22-NO. Debate ends.
- Vote on (CC8262020-4): 42-YES 41-NO. Motion passes to endorse Mary Nolan.
- ❖ Steve Hall, on behalf of the Endorsement Committee, moved (CC8262020-9) for the Washington County Democrats to endorse Gina Roletto for the Hillsboro City Council for the November 3rd General Election. Discussion.
- ❖ Chuck Riley moved (CC8262020-10) to dual-endorse. Seconded by Andrew Stiffler. Discussion. Vote: 18-YES, 65-NO. Motion to dual-endorse fails.

Seconded. Discussion. Vote: 73-YES unanimous
- ❖ Steve Hall, on behalf of the Endorsement Committee, moved (CC8262020-12) to grant a \$100 campaign donation to each of the following candidates for the Nov. 3 General Election: Elena Uhing, Donna Gustafson, Anthony Martin, Shawna Thompson, Kate Mohr, Sean Garland, Heidi Lueb, Jeanette Shaw, Valarie Pratt, Alex Thurber, Dean Moberg, and Gina Roletto. - ❖ Connie Chen moved (CC8262020-15) to limit debate on Ballot Measure Endorsements and immediately vote. Seconded. 43-YES 17 NO. Motion passes.

5. Special Report: Ballot Measure Endorsements

- ❖ Gerritt Rosenthal moved (CC8262020-16) to adopt the State Party Positions on the 4 Statewide Ballot Measures below. No Debate. Vote: YES-65 Unanimous. The motion passes.
 - State LRCA SJR 18 - Campaign Finance Limits
 - State LRSS HB 2270 - Tobacco and E-Cigarette Tax Increase for Health Programs
 - State IP 34 - Psilocybin Program
 - State IP 44 - Drug Decriminalization and Addiction Treatment
 - State IP 57 - Independent State and Congressional Redistricting Commission (DPO voted no):
- ❖ Veronica Williams moved (CC8262020-17) to take the DPO's position on State IP 57. Seconded. No Debate. Vote: YES-51, NO-17. Motion passes.
- ❖ Gerritt Rosenthal moved (CC8262020-18) to approve the Metro Council Referral - Transportation Funding & Business Payroll Tax. Seconded. Vote: YES- 58, NO-4. Motion passes.
- ❖ Garrett Fleenor moved (CC8262020-19) to place the vote on the Amendment to Special Rule of Order 4 and Standing Rules 4 and 5 on an online vote. John MacDonald seconded. Discussion. Vote: YES-45, NO-7. Motion passes for an online vote and results will be reported at the September CC meeting.

- ❖ Lisa Stiller moved (CC8262020-20) to send the following statement to the full Congressional Delegation and to vote online and Jim Silver seconded:
The Central Committee of the Washington County Democratic Party supports the US Postal Service. We support full funding of the US Postal Service with the \$25 billion requested to assure that post office delays do not impact the November election, and we support the Delivering for America Act of 2020 (HR 8015), passed by the House on August 22, which prohibits any changes to postal service operations that were in place as of January 1, 2020, and would, therefore, reverse the recent changes put in place meant to slow down mail delivery. We believe the ability to have a fair election and our democracy depends on both.
- ❖ Brett Hamilton moved (CC8262020-21) to suspend the rules and vote on Lisa Stiller’s motion now. Seconded. Not Debatable. Vote: 34-YES, 12-NO (2/3’s majority). Motion passes.
- ❖ Bridget Brooks moved (CC8262020-22) to change the language from Post Office to **Postal Service**. Seconded. Vote: Passes and changes (in red) made to the above statement.
- ❖ Vote on (CC8262020-20) as moved (CC8162020-21) and amended (CC8262020-22): Vote: 45-YES (unanimous). Motion passes.

Garrett Fleenor moved (CC8262020-23) to adjourn. Vote: YES-46, NO-1
