Report of the Campaign Committee

The Democratic Party of Washington County had another very successful election last week. Voter turnout in the election was 24% but it was 37% among those Democrats who received our postcards that listed the candidates we endorsed. Of our 18 endorsed candidates, 15 were victorious and one will be in a runoff in November.

Almost certainly our special effort of postcard mailings in Hillsboro contributed to our victories in three of the four hotly contested school board races. In addition to the mailings done by our Neighborhood Leaders, our office volunteers also mailed hundreds of postcards to Hillsboro Democrats. All four school board races had less than three percent separating the winners and losers. The only one of our endorsed candidates who lost was Jaci Spross in position 6.

The only other race where our endorsed candidate lost was the PCC Directors Position 7 where Reiko Mia Williams was defeated by another Democrat, Kristy Wilson.

There will be a runoff on September 21 for Beaverton City Council, Position 1. According to the updated election results released today, our endorsed candidate, Ashley Hartmeier-Prigg, just missed winning outright, with 49.02% of the votes. She will face Jerome Sibayan who received 38.54% of the votes.

The next major election we will have will be the Primary in 2022. By then we expect to have our Neighborhood Leaders knocking on doors again. However, we still will be using postcards in rural areas and we may augment our canvassing in other selected areas with postcards.

The Neighborhood Leader program, originally developed here in Washington County, has been tremendously successful first in converting the county from red to blue and now continuing to keep the county blue.
